**PETITION FOR DISSOLUTION OF MARRIAGE WITH DEPENDENT OR  
MINOR CHILD(REN)**

I, Tweety Bird being sworn, certify that the following statements are true:

1. JURISDICTION/RESIDENCE

Both spouses have lived in Florida for at least 6 months before the filing of this Petition for Dissolution of Marriage.

2. NEITHER PARTY is a member of the military service.

3. MARRIAGE HISTORY

Date of marriage: February 11, 2001

Date of separation: May 26, 2014 (This date is approximate)

4. DEPENDENT OR MINOR CHILDREN

a. Neither spouse is pregnant.

5. A completed Family Law Financial Affidavit, Florida Family Law Rules of Procedure Form 12.902(b) or (c) is filed with this petition.
6. A completed Uniform Child Custody Jurisdiction and Enforcement Act (UCCJEA) Affidavit, Florida Supreme Court Approved Family Law Form 12.902(d), is filed with this petition.
7. A completed Notice of Social Security Number, Florida Supreme Court Approved Family Law Form 12.902(j), is filed with this petition.
8. This petition for dissolution of marriage should be granted because the marriage is irretrievably broken.

#### **SECTION I. MARITAL ASSETS AND LIABILITIES**

There are marital assets or liabilities. All marital and nonmarital assets and liabilities are listed in the financial affidavits, Florida Family Law Rules of Procedure Form 12.902(b) or (c), filed in this case.

All marital assets and debts have been divided by a written agreement between the parties, which is attached to be incorporated into the final judgment of dissolution of marriage.

#### **SECTION II. SPOUSAL SUPPORT (ALIMONY)**

Petitioner forever gives up her right to spousal support (alimony) from Respondent.

#### **SECTION III. PARENTING PLAN ESTABLISHING PARENTAL RESPONSIBILITY AND TIME-SHARING**

1. The minor or dependent children currently reside with Tweety Bird.
2. **Parental Responsibility.** It is in the children's best interests that parental responsibility be shared by both parents.
3. **Parenting Plan and Time-Sharing.** It is in the children's best interests that the family be ordered to comply with a Parenting Plan that includes parental time-sharing with the children. The Petitioner states that it is in the best interests of the children that the attached proposed Parenting Plan should be adopted by the court. The parties have agreed to the Parenting Plan.
4. Explain why this request is in the best interests of the children: All issues have been amicably resolved between the parties with the best interests of the children in mind.

#### **SECTION IV. CHILD SUPPORT**

1. Petitioner requests that the Court award child support as determined by Florida's child support guidelines, section 61.30, Florida Statutes. A completed Child Support

Guidelines Worksheet, Florida Family Law Rules of Procedure Form 12.902(e), is filed. Such support should be ordered retroactive to the date of the filing of this petition.

2. Petitioner requests that medical/dental insurance for the minor children be provided by both parents.
3. Petitioner requests that uninsured medical/dental expenses for the children be paid by both parents (each pays one-half).
4. Petitioner requests that life insurance to secure child support be provided by the other spouse.

**SECTION V. OTHER**

No other relief requested.

**SECTION VI. REQUEST**

Tweety Bird requests that the Court enter an order dissolving the marriage and:

1. distributing marital assets and liabilities as requested in Section I of this petition;
2. awarding spousal support (alimony) as requested in Section II of this petition;
3. adopting or establishing a Parenting Plan containing provisions for parental responsibility and time-sharing for the dependent or minor children common to both parties, as requested in Section III of this petition;
4. establishing child support for the dependent or minor children common to both parties, as requested in Section IV of this petition;
5. awarding other relief as requested in Section V of this petition; if any, and any other terms the Court deems necessary.
