

LAST WILL AND TESTAMENT

OF

MICKEY MOUSE

I, MICKEY MOUSE, of Osceola County, State of Florida, declare this instrument to be my Last Will and Testament (“Will”) and hereby revoke all my prior wills and codicils.

ARTICLE A. Family

I am married to Minnie. I have no living or deceased children.

ARTICLE B. Effect of Future Events

This Will shall remain effective notwithstanding any subsequent marriage of mine. This Will is made in contemplation of the possible future birth of a child or children to me, or the adoption of a child or children by me, and shall remain effective notwithstanding any such birth or adoption.

ARTICLE C. Payment of Debts and Funeral Expenses

I direct that my body be buried in a suitable manner and that a suitable memorial be erected. I direct that a funeral be held for me at Sleepy Hollow Mortuary, and that my children sing "Amazing Grace" as part of the program.

I direct my Personal Representative to pay out of the residue of my estate, without apportionment and with no right of reimbursement from any recipient of any such property, as soon after my death as my Personal Representative deems consistent with good management, the expenses of my last illness, funeral and burial expenses not otherwise provided for, debts and claims duly allowed against my estate, and expenses incurred in the administration of my estate.

ARTICLE D. Disposition of Estate

E. Tangible Personal Property List. If there are in existence at the time of my death one or more written statements or lists signed by me which dispose of certain items of tangible personal property (excluding money, evidences of indebtedness, securities, and tangible personal property used in any trade or business in which I have an interest), they shall govern the disposition of those items not otherwise specifically disposed of in this Will. If there are any conflicting gift designations on or between one or more such statements or lists, the latest designation shall prevail. If any designated beneficiary fails to survive me, the gift to such beneficiary shall lapse.

F. Gifts of Specific Property. I hereby give the following described items of property, real and/or personal, to the following identified beneficiaries. If any beneficiary fails to survive me, the gift to such beneficiary shall lapse.

Checking account at Disney Bank to Tweety Bird.

House at 100 Main Street, Disneyworld to Minnie.

G. Cash Gifts. I hereby give the following sums of money, from such source or sources as my Personal Representative shall direct, to the following identified beneficiaries. If any beneficiary fails to survive me, the gift to such beneficiary shall lapse.

The sum of One Thousand Dollars (\$1,000.00) to Donald Duck.

The sum of One Thousand Dollars (\$1,000.00) to Huey, Dewey, and Louie.

H. Residuary Estate. After reduction for all expenses, debts, claims, and for any and all other devises created in this Will, I give all of the rest, residue, and remainder of my property and estate, whether real, personal, or mixed, of whatever kind and wherever located, including any lapsed, disclaimed, or void devises, together with any property over which I may have a power of disposition or appointment (my "residuary estate"), to Walt, currently residing at Chief Executive Offices, Disneyworld , if he survives me. Any portion of my estate not disposed of by the preceding devises shall pass to Legal Aid.

I. Insurance and Indebtedness. All property passing under this Will, whether real, personal, or mixed, including any tangible personal property passing under the one or more written statements or lists referenced above, shall pass subject to any indebtedness secured thereby as of the time of my death and shall include any and all insurance policies on such property and the proceeds of such insurance policies.

ARTICLE 1. Appointment of Personal Representative

I nominate and appoint WILEY COYOTE, currently residing at 101 Canyon Road Drive, as my Personal Representative.

ARTICLE 2. Powers and Obligations of Personal Representative

J. In the management, care, and disposition of my estate , I confer upon my Personal Representative the power to do all things and execute such instruments as may be deemed necessary or proper, including all powers conferred by law upon Personal Representatives in this State. All such powers may be exercised without order of or report to any court.

K. All successor Personal Representatives shall have all the powers, authorities and duties granted herein as if originally named to such position, and no successor Personal Representative shall be required to inquire into or audit the acts or actions of any predecessor Personal Representative or to make any claim against such predecessor Personal Representative.

L. No Personal Representative named herein, whether or not a resident of the State of Florida, shall be required to file any inventory or appraisal or any annual or other returns or reports to any court or to give bond.

M. My Personal Representative shall keep full accounts and shall make and furnish statements of all receipts and disbursements at least annually to each person then eligible to receive a distribution from my estate and shall at any time, upon reasonable request of such

person, provide full information to such person as to the condition of my estate, including amounts received and disbursements made.

N. Any Personal Representative named herein, whether initial or successor, may resign without the order of any officer or court and without the consent of any beneficiary of any provision of this Will upon giving such Personal Representative's successor, and all persons then entitled to receive distributions from my estate, or any guardian or conservator of such persons, thirty (30) days advance written notice of such Personal Representative's intention to resign.

ARTICLE 1. Joint Property

All securities, bank accounts, savings and loan accounts, certificates of deposit, and other similar property I may own at the time of my death in the name of myself and any other person which are by their terms payable on or after my death to such other person shall be the sole property of such other person, and my Personal Representative shall make no claim against such other person on account thereof.

ARTICLE 2. Rules of Construction

O. Governing Law. All questions as to the validity and construction of this Will shall be governed by the laws of the State of Florida. Except as otherwise provided in this Will, all terms in this Will shall be as defined in the Florida Probate Code effective as of the date of this Will.

P. Survivorship. For purposes of this Will, a beneficiary shall be deemed to have survived me only if it is established by clear and convincing evidence that such beneficiary is living on the date that is thirty (30) days after the date of my death.

Q. Inapplicability of Anti-Lapse Statute. A devise under this will that is subject to the condition that the devisee survive me shall lapse if the devisee fails to survive me. No statute or rule of law shall alter that result.

R. Adopted and Unborn Children. An adopted child or descendant shall be considered as descended from the person referred to only if such child or descendant was adopted prior to attaining the age of 18 years. A child in gestation who is later born alive shall be considered a living child throughout the period of gestation.

S. Other Principles of Construction. Words in one gender include such other gender as is appropriate. The singular includes the plural and vice versa. "Pay" and "distribute" also mean assign, convey, and deliver. The headings and underlined paragraph titles are for reference only and shall have no significance in the interpretation of this Will.

IN WITNESS WHEREOF, I, MICKEY MOUSE, the testator, sign my name to this instrument as my Will on this ____ day of February, 2017, and do hereby declare that I sign it willingly as my free and voluntary act, and that I am 18 years of age or older, of sound mind, and under no constraint or undue influence.
